The Green Leader – Skanska receives two awards at the 9th CEEQA Industry Awards Gala

During the CEEQA 2012 Industry Awards Gala, which took place on 17 April 2012 at the Warsaw Marriott Hotel, Skanska Commercial Development Europe was awarded twice – the company received the **Green Leadership Award** and the title of the **RealGreen Developer of the Year**. Awards in the RealGreen category for outstanding business performance and achievement in the field of sustainable construction were presented for the first time this year. Skanska was recognised for its commitment to develop new projects according to the principles of sustainable development, as well as promoting the idea of green construction in Central and Eastern Europe.

"We are very proud that we have been recognised as the green business leader for the second time in a row. All our projects are future-proof, which means that both the construction process and project performance have a minimal impact on the natural environment. With our 7 on-going projects in the CEE region we will soon deliver a total of 150,000 sqm of green office space," said Nicklas Lindberg, President of Skanska Commercial Development Europe.

All the projects carried out by Skanska Commercial Development Europe are designed and created in compliance with the criteria of LEED and EU GreenBuidling certification systems. The company is currently working on 7 projects located in Warsaw, Łódź, Poznań, Wrocław, Prague and Budapest. In the next few months Skanska CDE is going to start 6 more projects and will have a total of 240,000 sqm in its project portfolio.

Five out of seven on-going projects are being developed in Poland. In 2011, Skanska Property Poland launched its flagship project – Atrium 1 in Warsaw to be located at the ONZ Roundabout, in the very centre of the city. It will be the first Deep Green building in Central and Eastern Europe. According to Skanska's Color Palette, the term "Deep Green" refers to a building with nearly zero impact on the natural environment. During the construction and design process of Atrium 1, a number of highly innovative solutions and energy-efficient technologies have been implemented. As a result, the building's impact on the natural environment will be reduced and the operating costs will decrease, in particular, due to lower bills for water and electricity.

Skanska does not limit its activity to increasingly ambitious solutions in the field of green construction. The developer also puts great emphasis on educating tenants in terms of sustainable development and would like them to be able to benefit as much as possible from the solutions which the company offers them.

Skanska also supports its tenants in establishing relations with its business partners who share the commitment to green. Recently the developer signed contracts with STENA (waste collection and recycling) and TAURON (energy from renewable sources to be supplied to its green office buildings).
